#### **WORK SESSION**

Bill Prenocil (OFCC) updated the board on the possibility of a formal offer of state funding. The earliest would be July 2020. Jeff Tuckerman (Hammond Construction) reviewed master plan options including segmentation. David Conley (Rockmill Financial) updated the district's assessed valuation and millage options. Emily Cannon (PNC Capital Markets) gave an update on the current interest rate environment. Andrew Hawkins reported on enrollment. The board discussed next steps, which include waiting for administration appointments by the new governor and any potential changes in legislation. **MCESC Business Advisory Council Presentation** – Doug Hiscox of the Mahoning County ESC presented the Mahoning Valley Business Advisory Council Plan of Action 2018-2019. The plan identifies Strengths, Weaknesses, Opportunities, and Threats as well as Action Steps for addressing these issues.

#### **Community Comments:**

Dan Paulus (3217 Bent Oak Trail): 42 of 90 students have D's or F's in 8<sup>th</sup> grade ELA. Feels this needs to be addressed. Feels Engrade should be better utilized or is this business as usual.

A. Waesch: This is not business as usual.

A. Hawkins and R. Campbell both responded there were 3 failures last semester.

Craig Wise: (3894 Phile Dr.) 37 students failed last year with D's or F's.

Dan Paulus: Straight A students are failing in this class. What is being done to address this?

E. Kline: Last year the board heard concerns regarding books in 9<sup>th</sup> grade and did make changes.

Tom Weese (5015 Wilkes Rd): Has concerns books being read in the classroom are slanted in one political direction. Is anyone looking at curriculum?

T. Hrina-Treharn: No forms were filed to request new supplemental materials

Dan Paulus: Is there a cost for Engrade? It is an excellent tool

A. Hawkins: There is a cost. Next year the program is changing.

Dan Paulus: This helps parents know if students are turning in homework. Is it required that teachers use it?

A. Waesch: The board is aware of issues in 8<sup>th</sup> grade and is looking into it. We were proactive last year with 9<sup>th</sup> grade. The board is actively working to address the issues.

Tom Weese: All six books read this year were on the holocaust or racism. Feels this is presenting one particular political view. Feels there is an agenda. The students need to read something normal like Moby Dick.

S. Krieger: Do you feel the students are not up for the material? Or are disinterested?

Tom Weese: My son enjoys reading but needs a break from this curriculum. Feels this involves the English Dept as a whole

Steve Vasbinder: The choice of reading material was supposed to be interesting. Feels the material is directed at them as a group. It is not connecting with teenage boys.

Tom Weese: Some books on this issue are ok. But not all of them.

Dan Paulus: Do kids who fail go to summer school? Do teachers get paid when kids fail?

A. Hawkins: There's no summer school for middle school. At the high school, if credit is needed to graduate, they can do a credit recovery class online. Teachers get paid to grade the essay portion of the class. The 9<sup>th</sup> grade teacher is no longer doing it.

A. Waesch: If you check the minutes, you will see there was discussion on this.

Craig Wise: What is the avenue for tutors? Do you have to get on an IEP?

A Hawkins: A child must qualify for an IEP. They can't just be assigned one. In the past we have had tutors but we currently do not have one.

Craig Wise: Feels this is an academic emergency. Why are you not addressing it?

A Waesch: This has just been brought to our attention officially tonight. We can't make promises regarding outcomes, but we are addressing it.

E. Kline: As parents we are noticing issues because our children are at that age and as coaches our athletes are that age. The board is addressing the issue.

Tom Weese: At the elementary, there were 65 students on the honor roll. Now in 9<sup>th</sup> grade kids are failing. What is happening?

A Waesch: As a parent I know the elementary school so I am learning. You have our attention. Thank you for caring and for showing up to address your concerns to the board.

Jason Edwards (5115 Industry): New to the district with three straight A students. Now they are getting C's in ELA and A's in all other subjects. He has talked to the principal. He checked Engrade a week before the semester was over. Last grade entered was six weeks old. It is impossible for a parent to follow up. Comments by teachers have made his children feel belittled. As a coach he checks Engrade to make sure his athletes are eligible. It is a great policy to let students retest but what if they forget? How can the district help? As a coach, he sees the same kids struggling year after year. In Sept. and Dec. this was brought up to the teacher. Feels politics should not be in the classroom. His son posted a photo on social media which resulted in him getting assaulted. Was not happy but did not pursue legally. During the anti-bullying seminar his son was called out and embarrassed. His son had been suspended and they thought the issue was over once he took his punishment. Elec Simon presented his anti-bullying seminar at the high school and middle school. They were two different programs. Twitter feed showed "setting white kids straight". Nothing was said to the student who

Exhibit C assaulted his son. Only phone call he received was from Mr. Conley. Asks how to make this right with his son. Teachers are bringing their politics into the classrooms. When the district brings in politics, it creates a divided student body.
